_____ **PICK OF THE LITTER PUPPY FEE BY CHOICE OF STUD OWNER.**

- Conditions of pick of the litter fee: Stud dog owner agrees to make pick on/or before 9 weeks of age. Should only one puppy constitute the litter at 9 weeks of age, subject puppy shall be choice of the litter and payment in full for this mating, with a return service given to this bitch on her **next** heat cycle. (Stud owner and bitch owner to circle fee choice and initial).

Bitch owner agrees to begin puppy immunizations following AVMA guidelines. **Bitch owner will not place any puppies before 8 weeks of age.**

STUD OWNER AGREES TO:

Mate listed dogs only.

- Supply bitch owner with four generation pedigree on return of the bitch and payment of stud fee or before at time of review of stud dog.
- Take normal adequate care of the bitch while in the stud dog owner's care (Hand feed if necessary).
- Sign litter registration papers after the puppies are ten (10) days old.
- Provide a return service of the same stud to the same bitch if no pregnancy results from this mating.
- Stud owner has the right to veterinary proof of non-conception. To receive return service, bitch owner must notify stud owner of failure to conceive in writing not more than 90 days following mating (one month after puppies are due). If stud dies or is no longer owned by this owner, stud owner reserves the right to offer a different stud to the bitch owner. INITIAL _____.

BITCH OWNER AGREES TO:

- Pay stud fee when bitch is bred.
- Provide four generation pedigree when delivering bitch to be bred or when evaluation of bitch is performed by the stud dog owner.
- Provide veterinary signed affidavit stating that the bitch has proof of negative brucellosis test results. Failure of bitch owner to provide this will authorize stud owner to have veterinarian do brucellosis test at the expense of the bitch owner.
- Send bitch in good health and ready for breeding according to the guidelines of the stud dog owner.
- Notify stud owner in writing no later than 90 days after mating if no pregnancy results from the breeding. Failure to provide written notification within 90 days will result in no return service.
- Keep bitch properly confined following breeding to ensure no other dog could accidentally breed her before breeding season is entirely over.
- Agrees to not knowingly sell or transfer puppies whelped as a result of this mating to any firm connected with the resale or wholesale of dogs/puppies.

OTHER CONDITIONS

- _____ PUPPIES BORN DEAD OR ALIVE CONSTITUTES A LITTER. If only one puppy results from this breeding, a return service will be offered to the same bitch on her next season, provided all conditions of this _____ contract have been met.
- If Bitch fails to conceive on a return service, this contract is terminated.
- Any return service must take place on the **next regular season**. Bitch owner must keep updating the stud dog owner on the progress of the bitch as not all females come in season on a regular 6 month basis.
